


The Mission of the Wyoming County Soil and Water Conservation District is to promote wise management of our natural resources through a wide variety of quality conservation and educational programs.

# Schie Family Farm Barnyard Runoff Management Project



Covered Barnyard Project: Schie Family Farm, a beef operation in Attica, began their partnership with the Wyoming Co. SWCD to improve their barnyard runoff management in 2023. With the farms 45 beef animals concentrated in the barnyard, clean rainwater mixed with the manure and feed spoilage creating nutrient laden runoff that made it's way to a tributary to the class A, Tonawanda Creek.

With assistance from a professional engineer, it was determined that covering the barnyard to exclude clean rainwater and contain any pollutants was the best option. Utilizing existing and new concrete, a roof structure was constructed in addition to gutters, downspouts, underground outlets, and additional tile to carry clean rainwater away from the barnyard. The farm also implemented livestock exclusion fencing and drainage work to exclude further sediment pollution from wet areas in the barnyard.

Overall, this timely and successful project will positively benefit the Tonawanda Creek water quality, improve hoof health and animal comfort, and improve day to day management for the farm.















#### 2024 Conservation Farm of the Year

Rudgers Registered Jerseys, Attica NY

Since 1970, the Wyoming County Soil and Water Conservation District has recognized a farm in Wyoming County annually that makes exemplary efforts in the conservation of natural resources. Farms that are chosen have implemented a multitude of practices to protect water quality, reduce erosion, and improve soil health.

Lyman and Chelsey Rudgers milk 350 Jersey cows and raise all of their own young stock on their farm in Attica, while operating 500 acres to grow their crops. The farm has implemented numerous best management practices, both on their own and with assistance from the District and NRCS, that has led to improved water quality in the Tonawanda Creek Watershed.

Agricultural Environmental Management (AEM) is a tiered planning process designed by the NYS SWCC that helps farmers make sound decisions in protecting natural resources on their farms.

By participating in AEM, farmers can document their environmental stewardship, develop plans for future improvements that will positively impact natural resources, and contribute to a positive image of agriculture in their communities. Farms that meet certain criteria are also eligible to be awarded an AEM "Partnering to Protect Our Environment" sign.


